CHAIRMAN'S REPORT



The 2021/2022 financial year saw some normality return to the world following the slowing down of the COVID-19 pandemic, which saw us return to status quo in terms of working arrangements and events resuming.

One of the key events to return was Friendship Day in Gympie, which saw members travel from all over the state to reconnect with friends and meet new ones. A big thank you to Maureen, Linda, Lesley, and everyone else who contributed to make this event run seamlessly.

This financial year also saw the commencement of the "Transport Assistance Program", which was made possible through the generous grant from the Eastern Star Foundation. This program has enabled us to offer our members Cabcharge Vouchers, which they can use for taxi travel to and from AWWQ events, as well as funding bus trips for sub branches. With the grant we have also been able to purchase a 12-seat minivan which groups are able to utilize.

November 2022 will see State President, Jenny Gregory, step down as State President after a highly successful six-year term. Jenny's tireless work has been invaluable to AWWQ, and we are happy to say that her knowledge and skill set will not be lost as she will remain a Board Director of AWWQ. Thank you, Jenny.

This year marks AWWQ's 75th year in Queensland, following the formation of our very first sub-branch in Toowoomba on 8 August 1947. It is extremely pleasing to see AWWQ still running as strong as ever, many years following Mrs Vasey's passing. She has left a lasting legacy which will never be forgotten. To commemorate this special occasion, we distributed a commemorative 75th anniversary pin to all our members. We know members will wear the pin with pride.

In honour of Mrs Vasey's legacy, we have commissioned a statue of Jessie Vasey. The location of this statue, which is nearing completion at the time of drafting this report, is still to be determined. It will certainly be in Queensland- and further information will be provided once a location has been decided.

Our auditors UHY Haines Norton have audited the 2021/2022 Financial Report. You will note the members activities, functions and events, and sub-branch expenses are higher in comparison to last year. This is due to the recommencement of activities following the back end of the pandemic. This is pleasing to see as it indicates that social interaction is on the rise, which we know has a benefit on members health and wellbeing. We also have an investment portfolio, the returns which are used to support AWWQ operations. The portfolio is managed in three tranches, the current balances of which are:

Liquidity: \$906,827 (2021: \$847,849)
 Medium to Long Term: \$4,963,080 (2021: \$3,669,813)
 Long Term: \$1,936,977 (2021: \$3,010,269)

The Australian War Widows Queensland property portfolio has two permanent rental unit blocks (Marina Court in New Farm and Amity Place in Redcliffe), two holidays units in Caloundra and one rental unit in Redcliffe which is managed by Century 21. We also have two short-stay units in Marina Court for emergency accommodation.

I would like to thank you all for your continuing support of Australian War Widows Queensland, which enables us to continue our mission to empower, inspire and celebrate all war widows and families while providing whole of life support and assistance.

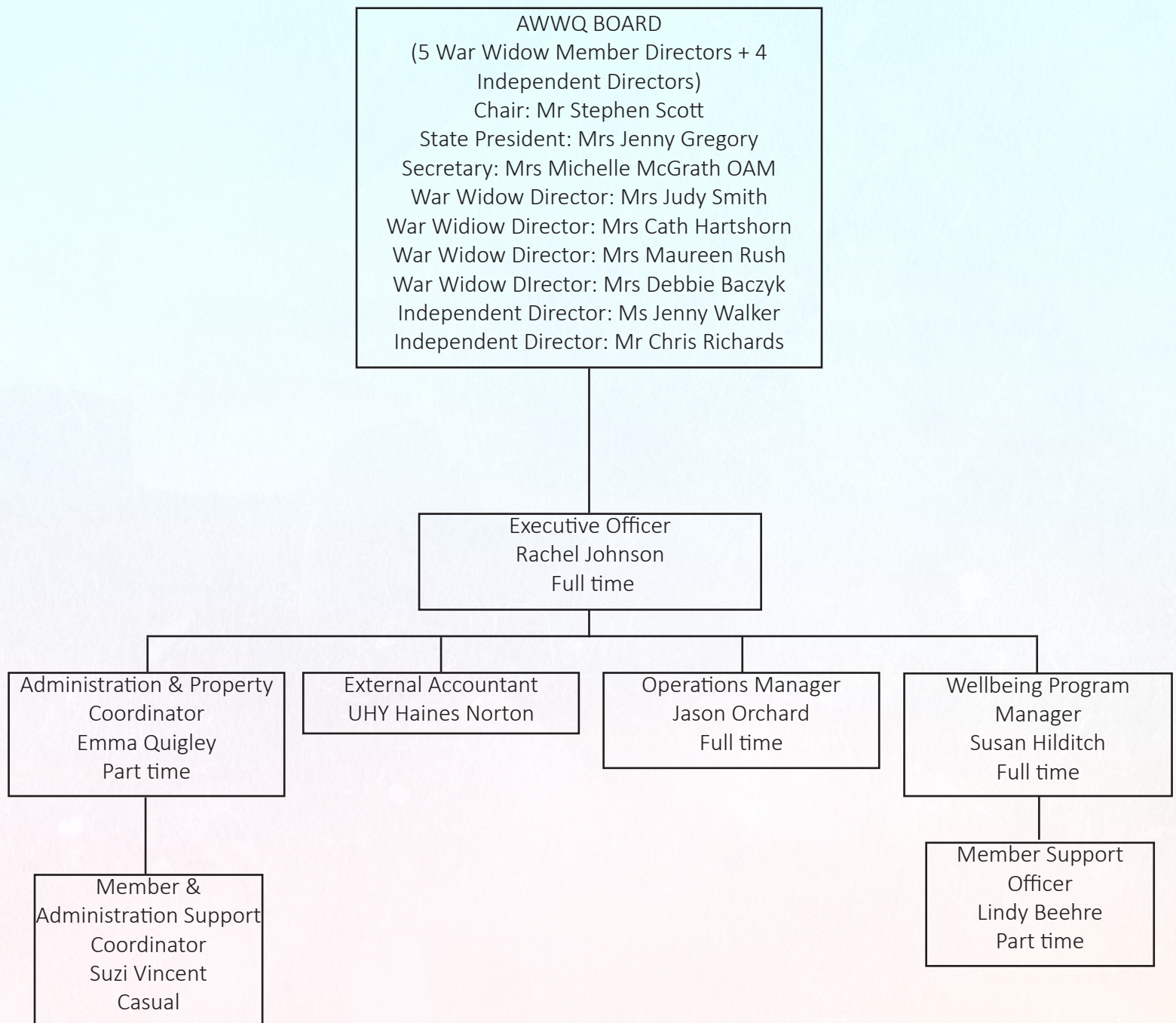

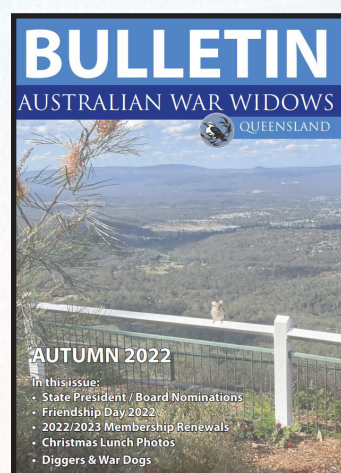
AWWQ ORGANISATIONAL STRUCTURE

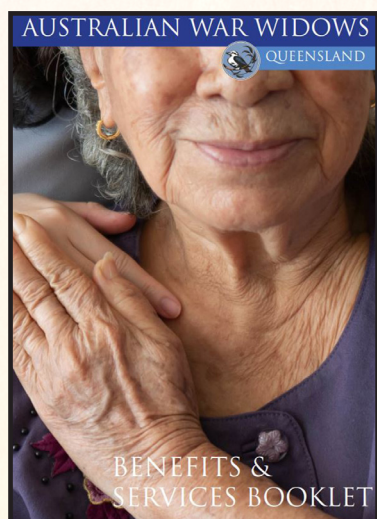
BULLETIN

WAR WIDOW'S DAY

Following the successful lobbying from the State President, we are extremely excited for Queensland's inaugural War Widow's Day which is to be celebrated each year on 19 October, the Birthday of our founder Jessie Mary Vasey OBE CBE.

This is a great achievement for Queensland being the first state to dedicate this day to War Widows, with other states now expected to follow.

Queensland Premier, Annastacia Palaszczuk, announced the news last year at the Jessie Vasey Day celebrations at Government House.

I can think of no better way to celebrate next year's 75th anniversary of what is now Australian War Widows Queensland than to formally dedicate this day as an annual recognition of the people left behind by those who have served Australia.

”

War Widows were generally the forgotten people during the war. While the husbands were away serving, it was up to the wives to keep the foundation strong at home. Jessie Vasey and her dedicated team fought long and hard to give War Widows a voice. One could only imagine her pride knowing her work was not in vein, and her message still stands strong some 75 years later.

AWWQ will dedicate a monument to its founder, Jessie Vasey, in 2023. The statue is being created by a Sunshine Coast Sculptor, and we are currently scouting for a location to erect it.

The Vasey family, with whom we have spoken, is delighted that Queensland is honouring Jessie Vasey with a statue and War Widow's Day.

Jessie Mary Vasey (nee Halbert) was born on 19 October 1897 in Roma, Queensland. In 1911, Jessie and her family moved to the Goulburn District in Victoria. Jessie attended the Methodist Ladies' College, Kew Melbourne, she matriculated in 1914. She then went on to study at the University of Melbourne (B.A. Hons).

Jessie met her husband, George Vasey, through George's sister, Marjorie. On 17 May 1921 George Vasey and Jessie Halbert were married. Their first child, a son called George Halbert Vasey, was born on 31 January 1925. A second son, Robert Alan, was born in 1932.

On 5 March 1945, after having returned home for medical treatment, George Vasey was returning to New Guinea to take up his command when the aircraft in which he was

traveling crashed into the sea off Cairns, killing Vasey and all on board. As the widow of a Major General, Jessie Vasey qualified for a widow's pension of sixty-eight shillings per week. Jessie realised that widows with small children needed to earn more than the basic pension but felt as mothers, they should be at home looking after their children.

Jessie approached Legacy for a list of widows, she placed advertisements in local Newspapers and wrote personally to over 2,400 widows from her own home. Jessie was proposing the formation of a craft guild. Some 300 war widows attended the inaugural meeting on 22 November 1945. A constitution was drawn up and office holders were elected, with Vasey being elected the first President. The War Widows' Craft Guild officially came into existence on 21 January 1946. The necessary resolutions were also passed to make the War Widows' Craft Guild a corporate body under the Victorian Patriotic Funds Act.

Following the formation of the Guild in Victoria Mrs. Vasey travelled around Australia organising guilds in other states. The Guild was established in New South Wales in June 1946, and by end of 1947 there were Guilds in every state. This enabled the formation of a federal organisation. Mrs. Vasey was elected founding president of the newly formed, War Widows' Guild of Australia at its first conference in 1947 and held that position until her death. Mrs Vasey also made contacts which would assist in the work of the Guild to improve the lifestyle of all war widows. Mrs Vasey passed away on 22 September 1966.

We are extremely excited and honoured to have this statue made, which will leave a lasting legacy of Mrs Vasey's hard work, dedication and inspiration to all war widows.

TRANSPORT GRANT



The transport grant funding awarded to Australian War Widows Queensland by Eastern Star Foundation, continues to assist our members to stay connected with fellow war widows.

The grant funds taxi travel for members who have difficulty getting to meetings and events. A war widow member has shared that she would previously take three buses to attend meetings.

“Prior to the Eastern Star Foundation grant, transport to and from meetings was always a struggle. The Cab-charge ticket scheme has not only drastically cut down travel time, but it has also made travel to meetings significantly more pleasant and comfortable.”

The grant also made provision for the purchase of a minivan, enabling sub-branches to enjoy a more personalised transport option and benefit from outings.

Members from Maroochydore and New Farm recently made use of the minivan visiting Mt Coot-Tha Botanic Gardens Information Centre, Freedom Wall and the War Widows' Guild memorial plaque at Roma Street Parklands, before sharing lunch together at Kedron-Wavell Club.



Australian War Widows Queensland Board Member Judy Smith said “Thank you to the Eastern Star Foundation for making these days possible. We all enjoyed the day out doing what our war widows love to do, meet with friends for an outing where they can chat and enjoy each other’s company over a cuppa and a meal”.

Another war widows member said, “It was a very interesting, informative, and enjoyable day. It was great to meet, chat and share a laugh or two”.

Australian War Widows Queensland State President Jenny Gregory spoke earlier in the year at an event, where Eastern Star Foundation committed to a further grant of \$50,000 to Australian War Widows Queensland in 2021.

“As we hear reports that depression and loneliness are considered major problems among elderly persons, we are increasingly grateful that thanks to your grant we can assist our members to continue to socialise and foster quality relationships.”

The concise financial report covers Australian War Widows Queensland as an individual entity. Australian War Widows Queensland is a not-for-profit Company, registered and domiciled in Australia.

The principal activities of the Company for the year ended 31 March 2022 were to watch over and protect the interests of war widows and providing suitable housing accommodation for members when such allocation is necessary.

The functional and presentation currency of Australian War Widows Queensland is Australian dollars.

Comparatives are consistent with prior years, unless otherwise stated. War Widows are providing suitable housing accommodation for members when such allocation is necessary.

1. Basis of Preparation

The concise financial report relates to Australian War Widows Queensland for the year ended 31 March 2022.

The concise financial report has been prepared in accordance with Australian Accounting Standard AASB 1039: Concise Financial Reports. The accounting policies adopted have been consistently applied to all financial periods presented unless otherwise stated.




