CHAIRMAN'S REPORT



2022/2023 was a productive year for Australian War Widows Queensland (AWWQ) and our members, with a major focus on social engagement for members, and Sub-Branch visits from State President Judy Smith and Wellbeing Program Manager, Sue Hilditch.

This year Judy Smith took over the reigns as State President and has been busy during her successful first year representing AWWQ at events and memorials, traveling around Queensland to meet as many members as possible, as well as being a vital voice on the AWWQ Board. Former State President, Jenny Gregory, was elected National President, a very well-deserved appointment. We are most fortunate to have both Jenny and Judy readily accessible to us all.

A memorable Friendship Day, preceded by a White Cross Service in ANZAC Park, was held in Redlands this year. The service gave members a chance to place a white cross in memory of their late partner. Both events were well attended by members, with plans well underway for next year's Friendship Day to be held in Brisbane.

Over \$30,000 of the Eastern Star Foundation Transport Assistance Grant provided members with transport assistance in the form of cab charges to Sub-Branch meetings, bus hire and use of the AWWQ Minibus to transport members to and from events. We are pleased to see members taking advantage of this generous grant and are grateful to the Eastern Star Foundation.

19 October 2022 marked the first annual War Widows' Day in Queensland. We were honored to host an event to celebrate this occasion at the Brisbane Convention Centre, which was attended by the Premier of Queensland Annastacia Palaszczuk MP, Her Excellency the Honourable Dr Jeanette Young AC PSM, members of the Vasey family and members of AWWQ. Landmarks around Queensland were illuminated in

blue on the night of the 19th of October to mark this occasion. We have now seen our friends in New South Wales, Australian Capital Territory, Western Australia and South Australia successfully gain recognition for this day.

Our social media presence is growing with over 700 followers on Facebook, which provides another way to keep members updated on important news and events.

Our auditors UHY Haines Norton have audited the 2022/2023 Financial Report. You will note travel expenses are higher in comparison to last year. This is the result of more members utilizing the Transport Assistance Grant, which is very pleasing to see. The investment portfolio managed by LAMBDA is held in three tranches. The carrying value of each tranche as at year end is as follows:

Liquidity: \$860,232 (2022: \$906,827)

Medium to Long Term: \$4,960,464 (2022: \$4,963,080)

Long Term: \$1,942,375 (2022: \$1,936,977)

The Australian War Widows Queensland property portfolio comprises two permanent rental unit blocks (Marina Court in New Farm and Amity Place in Redcliffe), with New Farm providing one short-stay unit for emergency accommodation, and one rental unit in Redcliffe managed by Century 21. Due to declining reservations, a decision was made in 2023 to sell one of the holidays units in Caloundra which was subsequently sold in October 2023. One unit remains for holiday accommodation.

I would like to thank all our members, directors and staff for their continuing dedication to AWWQ. This has enabled us to successfully operate for 76 years, providing services and advocating on behalf of War Widows in Queensland. The AWWQ Board is very appreciative of our Executive Officer, Rachel Johnson and her team for their excellent work.

We provide a collective voice for change. We advocate on current issues affecting war widows with the aim of protecting the interests of our members.

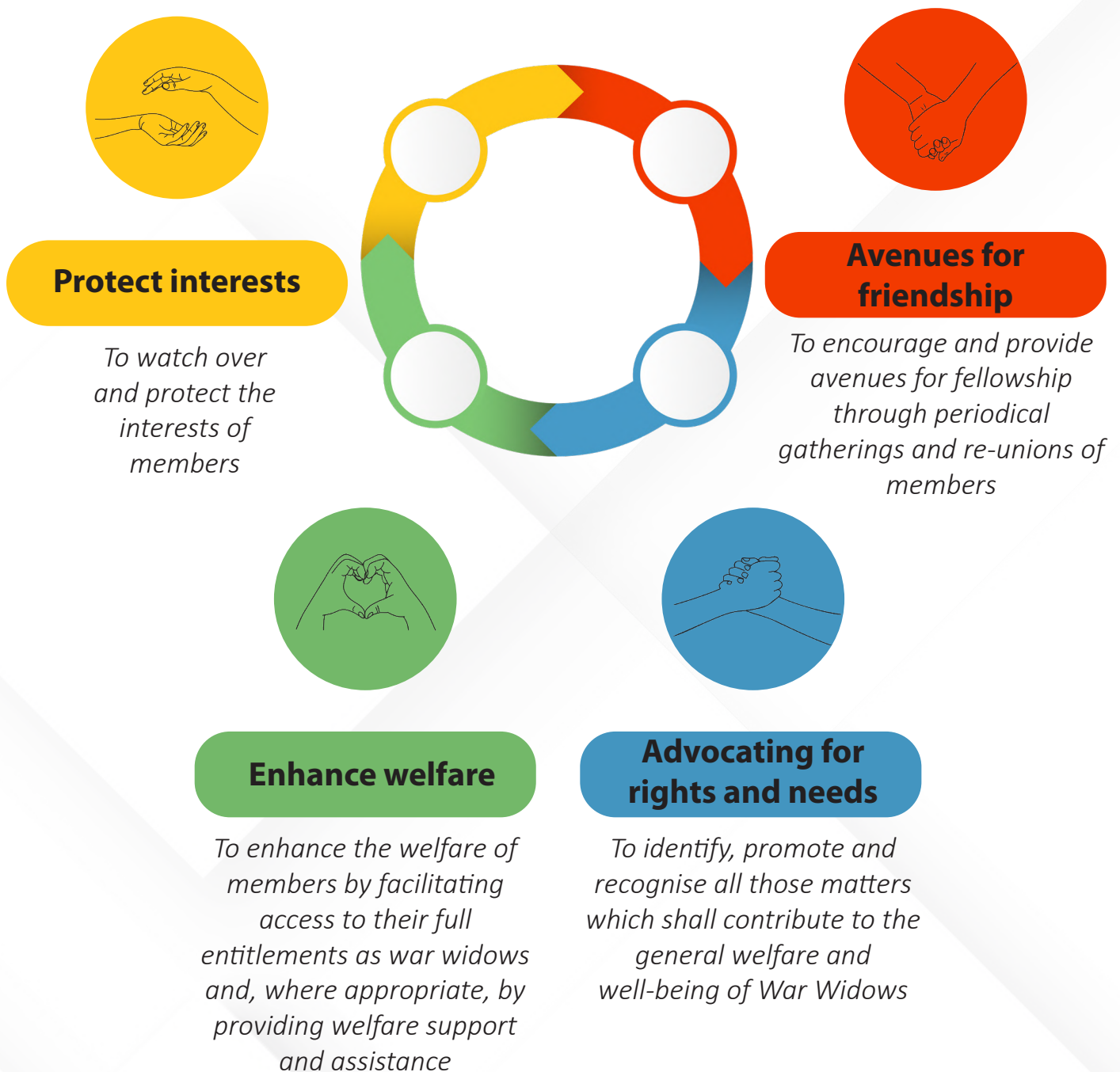
Friendship

Calls received by head office & member support calls to include question 'Do you have a NOK or 'trusted' person that you would like AWWQ correspondence to be sent to?'

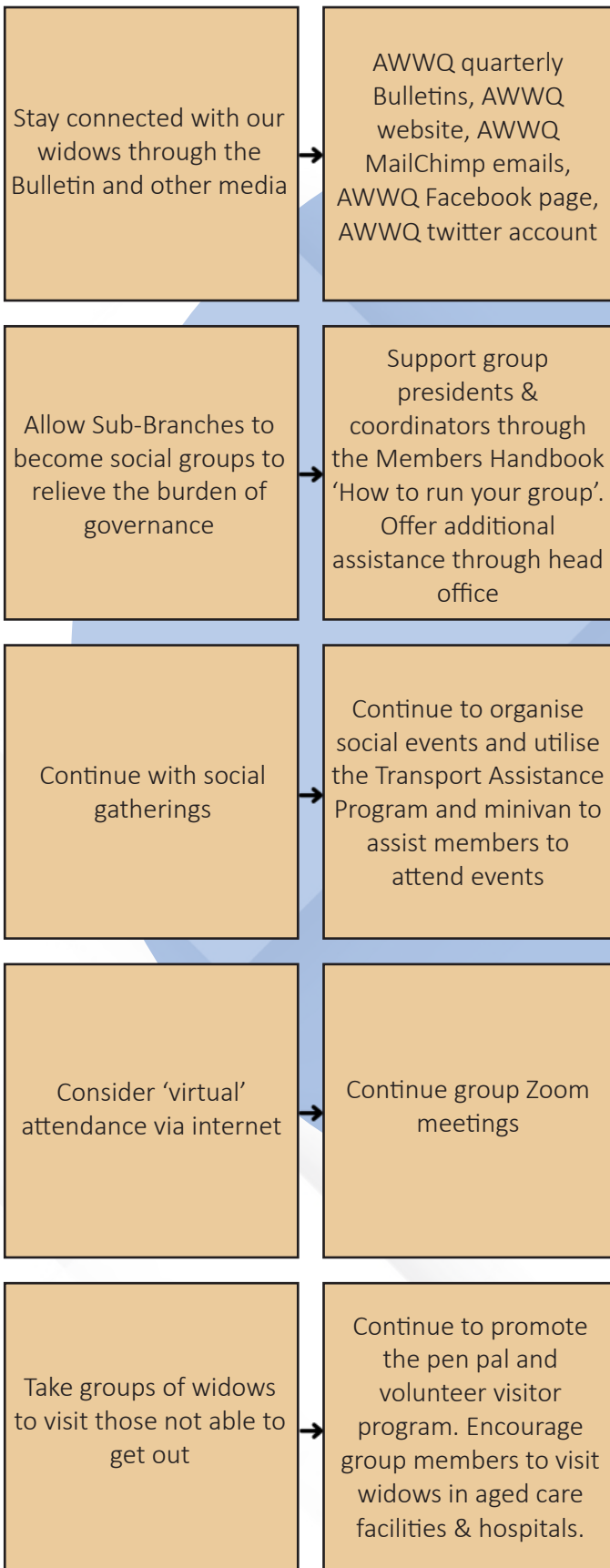

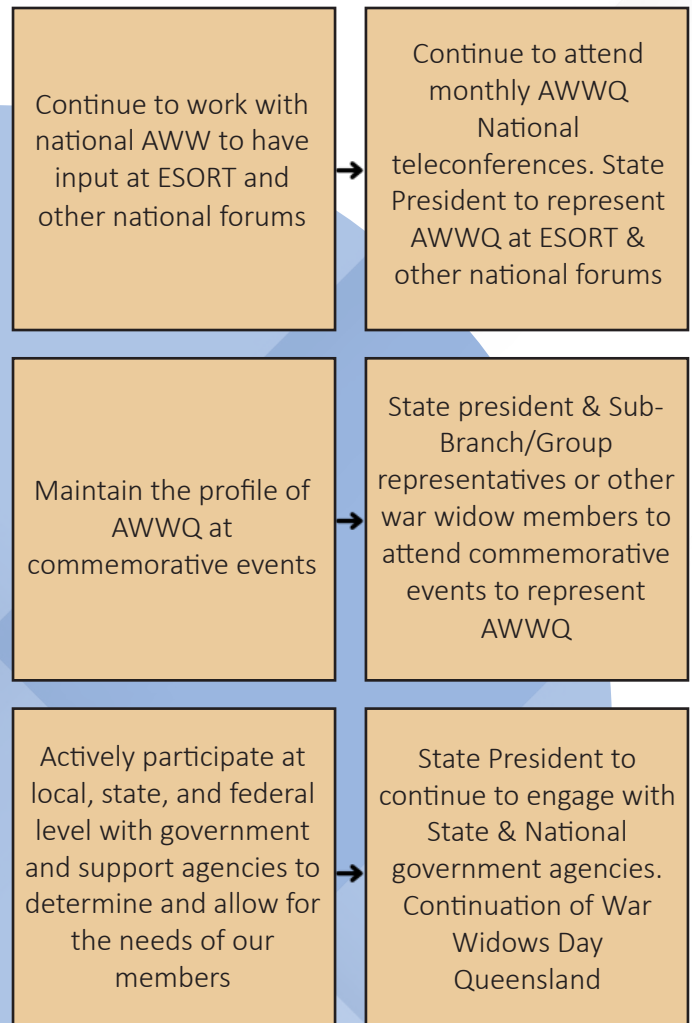

WAR WIDOWS' DAY



Mrs Jessie Vasey OBE CBE, was born on 19 October 1897, in Roma, Queensland. Following the passing of her husband, George Alan Vasey, she dedicated her life to proving support and giving war widows a voice when they were the forgotten victims of war.

On 22 November 1945, the War Widows' Guild of Australia was formed in Victoria, with the Queensland War Widows' Guild, now Australian War Widows Queensland (AWWQ) following suit on 8 August 1947. Jessie and her dedicated team worked tirelessly in establishing the War Widows' Pension, unfreezing of the Income Support Supplement,

lobbied for re-married widows to continue to receive the pension from their first husband, and established the provision of housing for war widows. On 22 September 1966, Jessie sadly passed away from cerebral thrombosis in Grafton, New South Wales.

The impact that Jessie Vasey had cannot be understated, with AWWQ celebrating 76 successful years in August 2023. On the 19th of October 2022, the birthday of Jessie Vasey, the state of Queensland celebrated the inaugural War Widows' Day, which was officially announced the previous year by

Queensland landmarks including the Story Bridge, Parliament House, Government House and Brisbane City Hall were all lit up in blue to mark the occasion. A War Widows' Day event at the Brisbane Convention and Exhibition Centre was held on the day which was well attended by members, members of the Vasey family, The Premier of Queensland Anastacia Palaszczuk MP and Her Excellency the Honourable Dr Jeanette Young AC PSM.

Former AWWQ State President and current National President, Jenny Gregory, played a pivotal role in lobbying for War Widows' Day "We are delighted that the Queensland Government continues to recognise the important work of Australian War Widows Queensland has formal dedicated 19 October each year to recognise loved ones left behind by those who have served Australia", Jenny explained.

AWWQ gives thanks to all war widows and their families for the sacrifices they have made.

The concise financial report covers Australian War Widows Queensland as in individual entity. Australian War Widows Queensland is a not-for-profit Company, registered and domiciled in Australia.

The principal activities of the Company for the year ended 31 March 2023 were to watch over and protect the interests of war widows and providing suitable housing accommodation for members when such allocation is necessary.

The functional and presentation currency of Australian War Widows Queensland is Australian dollars.

Comparatives are consistent with prior years, unless otherwise stated. War Widows are providing suitable housing accommodation for members when such allocation is necessary.

1. Basis of Preparation

The concise financial report relates to Australian War Widows Queensland for the year ended 31 March 2023.

The concise financial report has been prepared in accordance with Australian Accounting Standard AASB 1039: Concise Financial Reports. The accounting policies adopted have been consistently applied to all financial periods presented unless otherwise stated.

Shortly after the 31 March 2023 year end, the Directors approved the disposal of one of the Company's two holidays units at Centrepont Caloundra. Following the approval by the Directors, the Company commenced an active program to locate a buyer for the unit. In September 2023 the Directors accepted an offer to purchase the property which at the date of this financial report, was still conditional upon terms that are usual and customary for sale of such assets.





OPINION
